EXECUTIVE SUMMARY

The Annual Industry Report for the Fiscal Year 2023-2024 provides a comprehensive overview of the industrial sector's current status and the significant activities carried out by the Department of Industry (DoI) throughout the year. The DoI, as the leading agency, plays a pivotal role in formulating and implementing plans and programs aimed at the development and growth of industries in the country. This report accentuates the Department's commitment in supporting and facilitating both domestic industries and foreign investments, thereby driving the transformation and evolution of the industrial sector.

The industrial sector is a cornerstone of the nation's economic development, contributing substantially to employment, innovation, and overall economic growth. Recognizing this, the Department has focused on a multi-faceted approach to foster a vibrant and dynamic industrial environment. This report includes an overview of the industry sector, providing a broad overview of the current state of the industrial sector, including key statistics, trends, and a general assessment of the sector's performance over the fiscal year. Further, this report is structured into five detailed chapters, each addressing a critical aspect of the industrial landscape.

Chapter 1 focuses on policy and regulatory reforms, which detail the significant policy and regulatory reforms implemented to create a more favourable business environment, while Chapter 2 covers the business development support services, which focus on the support services provided by the Department, covering initiatives and programs designed to aid business development, including training, advisory services, and financial support mechanisms. Similarly, Chapter 3 focuses on innovation and technology adoption, highlighting the efforts made to foster innovation and the adoption of advanced technologies within the industry. Chapter 4 covers access to the market, addressing market accessibility, and highlighting strategies and initiatives aimed at improving domestic and international market access for local industries. Finally, Chapter 5 focuses on the access to infrastructure, which provides emphasis on the infrastructure developments that support industrial growth.

Through this report, the Department aims to provide a clear and detailed account of the progress made in the industry sector during the fiscal year 2023-2024. The Department of

Industry remains committed to driving the growth of a vibrant and dynamic industrial sector that contributes significantly to the economic development of the country.

OVERVIEW OF THE INDUSTRY SECTOR

The Industry sector in Bhutan is classified under scales of licenses such as large, medium, small and cottage, depending on the size of the capital investment. As shown in Table 1, an industry is categorized as a large industry if it invests Nu. 100 million and above with a minimum of 100 employees. Similarly, an industry is classified as medium scale if the investment size is from Nu.10 million to Nu.100 million and employs 20 to 99 people. Small-scale industries are those with investments between Nu. 1 million and Nu. 10 million with 5 to 19 employees. Likewise, a cottage industry is defined as an investment of less than Nu. 1 million with 1 to 4 employees.

0.1 Industry by Scale

As of June 20, 2024, there were 29,819 active industrial licenses in the country, but not all of them are operational. These licenses are valid as some industries are in the construction phase, while others were simply renewed to keep the business license active with the intention of starting or re-starting the business in the future.

The table above shows that the service sector predominates the overall industries, comprising 80% of the total. This is followed by the production and manufacturing sector at 13%, which represents an increase of 1% compared to the last fiscal year. The construction sector remains unchanged at 7%. However, the trend shows that compared to last fiscal year the number of active licenses has dropped.

0.2 Dzongkhag Wise Distribution of Industry

The graph below shows that the majority of the industries are clustered in the western and southern parts of the country, with a high concentration in Thimphu, Chhukha, Sarpang, Samtse, and Paro Dzongkhags. Gasa Dzongkhag has the least number of industries compared to other Dzongkhags, irrespective of the type and scale of industries.




Figure 1: Industry by Dzongkhag

0.2.1 Production and Manufacturing Industry by Dzongkhag

The graph below shows that Thimphu Dzongkhag has the highest number of production and manufacturing industries under the cottage and small scale (991 licenses) compared to large and medium scale (44 licenses) industries. Chhukha has the highest number of large and medium-scale production and manufacturing industries (87 licenses) followed by Samtse (82 licenses). The pattern is attributed mainly to the existence of industrial parks/other infrastructure and easier access to the raw materials- entry and exit points from India. Dzongkhags such as Gasa, Lhuentse, and Trongsa have the least number of manufacturing industries compared to other Dzongkhags.




Figure 2: Production and Manufacturing Industry by Dzongkhag

0.2.2 Service Industry by Dzongkhag

Service industries, irrespective of the scale of business activities, are mostly located in Thimphu with 3,768 small-scale licenses, 3,325 CRCs, and 211 medium and large-scale licenses, followed by Sarpang, Chhukha, Samtse, and Paro. Dagana and Gasa Dzongkhags do not even have a single medium and large service industries licensed.




Figure 3: Service Industry by Dzongkhag

0.2.3 Construction Industry by Dzongkhag

About 21% of contract licenses (433 licenses) are based in Thimphu, followed by 13% in Sarpang (265), and 9% in Chhukha (175 licenses). While contract licenses are concentrated in Thimphu, it is also widely spread across other Dzongkhags.




Figure 4: Construction Industry by Dzongkhag

0.2.4 Establishment by Legal Status (Ownership Type)

Industries are categorized based on legal status under sole proprietorship, partnership, company, and others (which include Groups, Cooperatives, Government-owned, Dratshangowned, etc.). About 96% of the total active industries are owned by sole proprietors, 3% by incorporated companies, 1% by partnerships, and a negligible share by other types of ownership, as depicted in the table below.




Figure 5: Industry by Owner Type

CHAPTER 1: POLICY AND REGULATORY REFORMS

1.1 Trade and Industry Rule 2023

The Trade and Industry Rules, 2023, was adopted and implemented on 22nd August, 2023. The objective is to streamline and provide clarity for the proper conduct of business, strengthen effective regulations, and create enabling environment for the promotion of entrepreneurship and the private sector at large. The Rules consolidate around 10 rules and regulations, guidelines, etc. related to trade and industry. It primarily aims to promote ease of doing business by simplifying the licensing process, eliminating the common barriers impeding business, and underscoring the rights and duties in the conduct of business activities.

1.2 FDI Rules and Regulations2024

The Ministry, as per the directive of the Government reviewed the FDI Policy in consultations with relevant stakeholders to enhance the investment climate in the country and consolidated the Policy and Regulations into a single document titled "FDI Rules and Regulations". The revised Rules & Regulations is expected to be endorsed by the first quarter of the upcoming fiscal year.

1.3 Membership to the World Association of Investment Promotion Agency (WAIPA)

The Department of Industry as an Investment Promotion Agency (IPA) has sought membership in the World Association of Investment Promotion Agency (WAIPA), a global reference point for FDIs where IPAs around the world engage in networking and share best practices of investment promotions. Being a member of WAIPA will increase the

visibility of Bhutan in the global investment landscape. Membership with WAIPA has been completed in June 2024.

1.4 Industry Census 2024

Industry census refers to a comprehensive enumeration that counts the entire population of operational cottage, small, medium, and large industries.

The Department in collaboration with the National Statistics Bureau, conducted a nationwide Industry Census 2024 - a complete enumeration of operational small, medium, cottage, and large industries in the country. The Reference period for the census was from January 1, 2023, to December 31, 2023. The census was led by 19 supervisors and 6 Dashboard Managers with the help of 113 enumerators.

To date, the System of National Accounts considered only those industries with books of accounts to determine their share of Gross Domestic Product (GDP) as it provided accurate data to calculate the value of goods and services produced within the country during a specific period of time.

For this census, to measure the impact and its contribution to provisional GDP, all operational industries in Bhutan regardless of their scale and maintenance of books of accounts were enumerated during the census.




Figure 7: Involvement in Industry Census 2024 by category

1.5 Informal SectorsDevelopment

For the reporting year, the Department in collaboration with **Dzongkhags** has supported the following informal activities with core equipment and machinery. As per the Guidelines for the Informal Sector Support 2022, strategic interventions for informal businesses intend to enhance contribution their to economic development and transit to the formal sector.

The Department received numerous applicants for informal support from various Dzongkhags for FY 2023-2024. The applications were screened using criteria such as but not limited to the use of local raw materials, employment generation potential, community development and import substitution potentials.

1.6 Industry InformationSystem (IIS)

The Industry Information System (IIS) is an online platform for industries to submit information electronically on their industries using in-built forms designed according to the scale and category of business. The information submitted by the industries will be utilized to prepare reports and aid in making data-driven planning and decisions.

Since the development of the Industry Information System in 2023, very few industries were provided with end-user training and the consequence was that all industries could not submit information as required. In the Fiscal Year 2023- 2024, the Department conducted a series of end-user training on IIS at Paro, Bumthang, Samtse, Pugli, Phuentsholing, Samdrup Jongkhar, Gelephu and Thimphu targeting more than 800 industries from Production and Manufacturing category.




Figure 9: ISS End User Training

1.7 Industrial Transformation Map

The Department initiated the development of the Industrial Transformation Map (ITM) in collaboration with the UNDP. The objective is to develop a medium to longterm industrial strategy focused on key priority sectors, based on comparative and competitive advantages, that will ultimately help build a developed Bhutan.

Moreover, the ITM will strive to develop sector-specific strategies (for prioritized sectors) to improve productivity, coordination, collaboration, and partnership with the private sector and guide us in our effort to become a high-income country driven by innovation and technology by 2034.

The following activities were carried out for the ITM project:

- UNDP fielded experts from UNDP's
 Istanbul Center for Private Sector
 Development
- Experts conducted Training of Trainers (ToT) for 13 participants from relevant agencies in February

- 2024 to build capacity to develop ITMs in the future.
- 3) Experts indicated five broad potential sectors for the development of ITM based on comparative and competitive advantages
- 4) Task Force selected three priority sectors for the development of ITM
- 5) Carried out a field survey of 25 industries falling under the prioritized sectors
- 6) Three sectoral workshops were conducted from 29-31 May 2024 with industry stakeholders
- 7) Final draft report on ITM for three prioritized sectors received.

CHAPTER 2: BUSINESS DEVELOPMENT SUPPORT SERVICES

2.1 Capacity Building

2.1.1. Digital Marketing Training

The Department in collaboration with the United Nations Development Programme conducted Digital Marketing Training in three Dzongkhags of Chukha, Punakha and Thimphu during the month of August 2023. A total of 77 CSIs (37 males and 40 females) attended the training.

The aim of the training was to enable CSIs to create awareness of their brand, build trust and confidence, and ultimately, promote e-commerce activities for the overall improvement of business performance.

Through interactive sessions and practical exercises, participants learned to apply digital tools and online promotion approaches, and learned about content marketing, email marketing and social-media marketing which is expected to help them promote their products and increase their overall business performance.

2.1.2 Training on Packaging and Labeling

For the FY 2023- 2024, packaging and labeling training was held in Paro, Bumthang, Gelephu and Samdrup Jongkhar Dzongkhag for wider coverage of the Dzongkhags. The aim of the training was to provide equal opportunities for both genders in the production and manufacturing sector. A total of 111 entrepreneurs with a nearly equal split of both genders (57 females and 54 males) participated in the training.

Labeling of the products during the training involved displaying essential details like the product name, ingredients, usage instructions, and legal information, ensuring compliance with regulations. On the other hand, packaging primarily concerns the material aspect, such as using plastic, glass, metal, or paper to encase the product physically. The training enabled the CSIs to professionally display their brand logo and messages that will help the customer find their product easily by creating a recall value.

The training was conducted by a packaging and labeling expert, Mr. Rajesh Iyer under ADB TA. During the training, participants were made aware of various business development support services of the Department which can be accessed at www.industry.gov.bt and also sensitized on Industry Information System developed by the Department.

2.1.3 Basic and Intermediate Digital Marketing and Content Creation including Photography and Videography Training for CSIs

As part of the ADB-TA *Improving Access* to *Market for the CSIs*, the 'Basic and Intermediate Digital Marketing and Content Creation including Photography and Videography for CSIs' training was conducted at Paro from 18 March to 6 April 2024. The training was participated by a total of 37 participants including the 12 selected CSIs with 15 males and 22 females.

The initial ten days were designed as a basic course while another ten days of training was a more intermediate level of training focused primarily on the 12 CSI producers. One of the primary outputs of the intermediate-level training was the production of a shorter version of the product videos of each CSI using the skills learnt during the training. Another output was an improvement of the social media pages of the CSIs.

2.1.4 CFC, Thimphu and Tsirang

The Department with technical support from National Post Harvest Center (NHPC) conducted user training from 13th to 15th November 2023 for the Common Center (CFC) Facility Operator Thimphu to ensure efficient and effective use of equipment/machinery in the CFC. The CFC is well equipped with the most commonly required equipment/machinery such as grinding, packaging, labeling, sealing, dehydrating, sorting, etc. primarily to provide the most commonly required services to startups and CSIs.

Similarly, for CFC at Tsirang, the user training was conducted for six days from 17th to 22nd November 2023. The main objective of the training was to practically acquaint the CFC Operator in handling and operating the installed equipment and machinery in providing the services. In addition, new equipment/machinery was added; new electrical wiring both single and three phase connections from the recently upgraded distribution substation completed; civil works was modification of processing rooms were executed and equipment also machinery were tested and the CFC has been made functional.

2.2 Business Advocacy Workshop

The Business Advocacy Workshop (BAW) is one such tool that enables the Department to advocate for potential entrepreneurs and as well as existing industries on how to obtain a business license by using online systems, and postlicense facilitation to industries such as recommendations for availing incentives. The platform is also utilized to disseminate information on current rules and regulations of the government to comply with while starting/operating their business and upcoming any new opportunities.

The workshop also provided a platform for participants to seek clarification and share issues.

In the Fiscal Year 2023-2024, the Department of Industry in collaboration

with the United Nation Development Programme) (UNDP conducted BAW at two Technical Training Institutes. During the workshop guest speakers were invited to share their journey as entrepreneurs with the participants.

Mr. Ngawang Yonten Rai was invited as a guest speaker at TTI in Samthang. He shared the pros and cons of starting and running his flour milling business in Khuruthang, Punakha. He talked about the motivational aspects of running a business and shared the support that he received from the Government.

Mr. Rinzin Dorji, owner of the Oat Manufacturing unit in Chumey, Bumthang was invited as a guest speaker to share his experience of starting and running his business with the participants. He shared how his establishment of

business helped local farmers to identify one more cash crop from just fodder for cattle in winter.

2.3 Licensing & Facilitation for Foreign Direct Investment

2.3.1 FDI Registration Certificate (FDIRC)

The Department of Industry facilitates the issuance of FDI Registration Certificates within five working days after receiving a complete registration application. The FDIRC is valid for a period of one year from the date of issue and the investor shall submit the documents for project approval within the FDIRC validity period. Upon issuance of an FDIRC, the business shall be entitled to a minimum of five work permits for professional, managerial and technical expatriates during the business establishment phase.

In the fiscal year 2023-2024, the Department issued a total of 25 FDIRCs for 25 different FDI companies.

2.3.2 Business Project Approval

The Department appraises and reviews FDI projects for approval and issuance of business licenses. In the fiscal year 2023-2024, a total of 16 new projects were approved for licensing. Of the 16 projects, 12 projects were in the services sector, and

the remaining 4 were in the production & manufacturing sector.

2.3.3 Other Post-License Facilitations (Location Change, Capacity Expansion, Additional (Activity)

The Department also facilitates the change in project cost, transfer of shares, approval for additional location and approval for additional foreign investors. In the fiscal year 2023-2024, the Department has approved the change in project cost for three industries, the transfer of shares for four projects, the approval for additional locations for one project and the approval for additional foreign investors for one project.

2.3.4 Investor Card

The Department facilitates the issuance of recommendations for the Investor Card and its renewal for Investors/Promoters of FDI companies. An investor card allows an investor of the FDI Company multiple entries and exits in the country. The card is issued for a period of one year and should be renewed annually. FDI companies must apply recommendation letter with a copy of their passports to the Department of Industry.

The particular investor must be physically present at the Department of Immigration to get his/her investor card.

During the fiscal year 2023-2024, the Department verified and recommended thirty-two investor cards.

2.4 Licensing for Domestic Investment Medium and Large Industries

2.4.1 Business Project Approval

The Department appraises and processes the medium and large-scale industries falling under the production and manufacturing category, and the services category for approval. In the fiscal year 2023-2024, a total of 56 new medium and large industries were approved for licensing.

Out of 56 approved industries, 14 industries were of large scale and 42 industries were of medium scale. In terms of the activity category, 21 industries were service-oriented and 35 were production and manufacturing industries.




Figure 18:Percentage of domestic medium and large industries approved in the fiscal year 2023-2024 by scale

2.4.2 Up-gradation of Industries

The Department promotes and facilitates the up-gradation of industries from small to medium and small/medium to large scale. The up-gradation of industries is mainly based on the enhancement of capital investment in the form of installation of additional machinery and equipment, and an increase in production capacity.

The Department verified and facilitated the up-gradation of 9 industries (6 production and manufacturing industries, 3 service industries), from which, 6 industries were upgraded to medium-scale and 3 industries were upgraded to large-scale.

2.4.3 Other Post-LicenseFacilitations (Location Change,Capacity Expansion, AdditionalActivity)

The Department also facilitates the change of location, expansion of capacity, and inclusion of additional activity for domestic projects. The scale of the industries remains unchanged in case of a location change. However, in the case of capacity expansion and the addition of activities, the scale of the industry may change if investment crosses the threshold.

In the fiscal year 2023-2024, the Department has approved 4 industries (3 large-scale; 1 medium-scale) for location change and 4 industries (3 large-scale, 1 medium-scale) for capacity expansion.

2.4.4 Monitoring of Industries and Approved Projects

The Department carries out monitoring of the industries through site visits to update the operational status of approved projects. The monitoring is also aimed at understanding the issues or challenges faced by the industries in terms of financial and market access. In the fiscal year 2023-2024, the Department visited 15 approved industries (3 production and manufacturing industries, 12 service industries) in Paro, Punakha and Wangdue Phodrang to assess the aforementioned components.

2.5 Environment Services

The Department is responsible for the issuance and renewal of environment Clearance (EC) for delegated activities. Furthermore, the Department is also responsible for forwarding the documents for non-delegated activities to the Department of Environment and Climate Change (DECC).




Figure 19: Environment services provided

The graph above shows that in the fiscal year 2023-2024 the forwarding documents for issuance of new Environment Clearance (EC) to DECC for non-delegated activities is 81, renewal and name change for non-delegated projects is

62 whereas issuance of new EC to delegated activities is 40 and EC renewal and name change for delegated activities is 181.

2.5.1 Compliance Monitoring of Projects

The Department also carries out regular inspections and monitoring of industries for compliance with environmental regulations and supporting industries for upgradation clean technology. to the Subsequently, Department also joint participated in the Annual compliance monitoring of projects within Pasakha Industrial Estate (PIE) and Phuentsholing Thromde.




Figure 21: Post license services for FY 2023-2024

An assessment of the post-license support services provided by the Department in the fiscal year 2023-2024, particularly on the number of facilitations reveals that 56.3 % of the post-license services availed are for import license, 21.3 % for facilitations related to fiscal incentives, 18 % for business guest visa facilitation, 0.9 % for facilitation related to access to convertible currency, 3.2 % for dissemination of industrial data and 0.3 % for facilitation related to work permit renewals.

2.6.1 Import License

The Department facilitates the import of machinery/equipment, raw materials (including packaging materials), spare parts, lubricants, temporary import of machines, and second-hand raw materials (HDPE bags) from third countries, required for the smooth functioning of all industries irrespective of the scale of business.

Under the Import License service, the Department facilitates new import licenses, import amendments, and import cancellations which are all facilitated online through the Bhutan TradeFin Net (BTFN) system. The Department also facilitates the import of lubricants, import

of second-hand raw materials (HDPE bags), and temporary import applications which are facilitated manually (offline). In the fiscal year 2023-2024, the Department verified and recommended the following applications as tabled below:

In the Fiscal year 2023-2024, the Department assessed and approved 546

new import licenses, 78 import license amendments, 21 import license cancellations, and 7 import license extensions. The Department also recommended 2 imports of lubricants, 7 imports of second-hand raw materials (HDPE Bags), and 2 temporary import licenses. Overall, the total approved applications increased from 359 in the fiscal year 2022-2023 to 664 in the fiscal year 2023-2024.

2.6.2 Business Guest Visa

The Department facilitates the issuance of recommendations for business guest visas as per the requirement of the Department of Immigration, Ministry of Home Affairs. All industries inviting business guests and investors must submit an application with other required documents to avail recommendations for business guest visas from the Department of Industry.

In the fiscal year 2023-2024, the Department verified and recommended 212 Business Guest Visa applications, a significant increase from the 98 applications in the fiscal year 2022-2023. Of this 212 applications, 106 were domestic industries and the remaining 106 were foreign direct investment industries.

2.6.3 Fiscal Incentives

The Department provides services that facilitate and support all industries in availing different types of fiscal incentives as per the Fiscal Incentives Act of Bhutan 2021 such as fiscal incentives for the import of capital goods, import of primary raw materials and packaging materials, investment allowance and recommendation for concessionary tax rate incentives.

In the Fiscal year 2023-2024, Department facilitated 38 applications for fiscal incentives for capital goods, 181 value addition certificates, recommendations for concessionary tax rate incentives, 11 certificates for local manufacturers of construction materials, and 12 recommendations for investment Overall, the Department allowance. witnessed an increase in total approved applications from 162 in the fiscal year 2022-2023 to 251 in the fiscal year 2023-2024.

2.6.3.1 Fiscal Incentives for Capital Goods

Import of capital goods (machines/equipment) from India and third countries are imposed sales tax and

customs duty as per the government rules. However, these levies are exempted to industries but it is subject to the recommendation from the Department as per the Rules on the Fiscal Incentives Act of Bhutan 2021. In the fiscal year 2023-2024, the Department verified and recommended a total of 38 applications for the exemption of customs duty and sales tax.

2.6.3.2 Value Addition Certificate

All traders importing raw materials (including packaging materials) from India and third countries are liable to pay sales tax and customs duty as per the government rules. However, these levies are exempted for industries but it is subject to the issuance of the Value Addition Certificate by the Department as per the Fiscal Incentives Act of Bhutan 2021. In the fiscal year 2023-2024, the Department verified and issued a total of 181 value addition certificates for the exemption of customs duty and sales tax for the import of raw materials and packaging materials thus indicating a huge increase from 109 certificates issued in the fiscal year 2022-2023.

2.6.3.3 Investment Allowance

The Department facilitates industries to avail the Investment Allowance from the government with the issuance of a recommendation letter as per the Fiscal Incentives Act of Bhutan 2021. In the fiscal year 2023-2024, the Department verified and issued a total of 12 recommendations for industries availing investment allowance.

2.6.3.4 Certificate for Local Manufacturers of Construction Materials

The Department issues industries with the certificate for local manufacturer of construction materials to assist industries in gaining a competitive advantage in the market by allowing its customers to avail fiscal incentives on using locally manufactured construction materials (30% additional tax deduction) as per the Rule on the Fiscal Incentives Act of Bhutan 2021. The certificate for local manufacture of construction materials is issued to the industries producing the construction materials, excluding timber, cement, sand, and stone chips & aggregate. In the fiscal year 2023-2024, the Department verified

and issued 11 certificates for local manufacturers of construction materials.

2.6.3.5 Recommendation for Concessionary Tax Rate Incentives

The Department facilitates all eligible industries to avail concessionary tax rate incentives as per the requirement of the Fiscal Incentives Act of Bhutan 2021. In the fiscal year 2023-2024, the Department verified and issued a total of 9 recommendations for concessionary tax rate incentives. This is a slight increase from the 8 certificates accorded in the fiscal year 2022-2023.

2.6.4 Renewal of Work Permit

The Department facilitates the issuance of recommendations for the renewal of work permit for the expatriate workers of the industries to be exempted from the 6-months cooling period of the workers after the expiration of their work permit.

In the fiscal year 2023-2024, Department verified and recommended 3 Renewal of Work Permit applications. This service has, however, ceased since the Department of Immigration relaxed the mandatory six-month exit requirement for foreign workers following three years stay in the country from November 11, 2023, as **Immigration** per Rules Regulations of the Kingdom of Bhutan 2023. Hence this justifies the reduction in the number of applications received and recommended for this purpose.

2.6.5 Facilitation of Access to Convertible Currency Clearance

The Department facilitates and assists industries to access Convertible Currency Clearance (foreign currency) from the government in order to help the industries import goods (capital goods, raw materials, and packaging materials),

remain in production, and compete in the market.

The website also serves as an interactive portal to certification the access and standardization services of Bhutan Food and Drug Authority (BFDA) and Bhutan Standards Bureau (BSB) and access Brand Bhutan services of the Department of Trade.

3.2 Investment Portal

An investment portal has been developed to provide information on business opportunities in different sectors, key information that an investor would want to know while deciding to choose an investment destination. The investors currently face issues such as accessing complete information on FDI policy, processes, incentives, etc.; connecting

local partners with foreign partners and vice-versa and information on investment opportunities. The online investment portal, therefore, is expected to resolve these issues faced by the investors. Additionally, through this portal the Department will be able to provide single window services to FDI businesses. The portal can be accessed from www.investbhutan.gov.bt

CHAPTER 4: ACCESS TO MARKET

4.1 CSI and Food Fairs

To celebrate and rejoice in the auspicious birth of Her Royal Highness The Gyalsem, the Department in collaboration with BAOWE organized the Tshechu Fair, 2023 from 23 to 26 September 2023 at the Clock Tower, Thimphu. Hon'ble Chairperson of the National Council graced the opening ceremony.

The Tshechu Fair served as a platform to showcase and promote local products and native cuisines, encourage inter-business networking for long-term relationships, and provide opportunities for youth and women entrepreneurs to market their innovative products. The event created awareness among the general public on the various locally manufactured products and gained patronage over imported products.

Representatives from CSIs, Startups, CSOs and Associations, and Grassroots Rural Entrepreneurs Women (GREW) participated in the fair.

4.2 CSI Market Outlet Outside Bhutan

The Department inaugurated the second 'Bhutan Store' in New York, United States of America on 28 July 2023. The virtual inaugural event was graced by Lyonpo Karma Dorji, Ministry of Industry, Commerce and Employment.

The main objective of establishing the Bhutan Store is to enhance international market access for locally manufactured products - one of the main barriers that hamper the growth and development of CSIs. The outlet will promote Bhutanese products, particularly high-value niche products, and earn convertible currency, encouraging CSIs to enhance value addition, upscale, and improve efficiency,

while generating employment opportunities in the country.

The 'Bhutan Store' in New York serves as a one-stop center for all CSI products from Bhutan. The store will initially target and serve the Bhutanese diaspora in New York and gradually increase its reach and presence in other parts of the USA. The 'Bhutan Store' is located at 45 Street, Woodside, New York City, USA.

The first Bhutan Store was established in Perth, Australia coinciding with the 115th National Day celebrations on 17 December 2022. To date, the Bhutan Store in Perth has been performing well due to the large number of Bhutanese diaspora in Western Australia.

4.3 Market Promotion for Locally Manufactured Products

4.3.1 Concrete Bricks Promotion

The local concrete brick manufacturers in the country have been facing market challenges owing to the access construction sector's preference for bricks. imported The Department conducted a survey of the contractors in July 2024 to understand their preferences for construction materials. It was found that 18% of the respondents exclusively use locally manufactured bricks, 21% exclusively prefer imported bricks and 61% used a combination of both imported and local bricks in their construction projects.

To address the market concerns for the local concrete brick manufacturers, the Department spearheaded the efforts toward the promotion of local bricks in collaboration with the Bhutan Standards Bureau (BSB, MoICE), the Department of Infrastructure Development (DoID, MoIT) and the Department of Procurement and Properties (DPP, MoF). A 'Strategic Plan for the Promotion of Local Bricks in Bhutan' was developed and published for implementation in October 2024.

The plan mainly recommends the issuance of a revised version of the previous executive or government notifications on the use of local concrete bricks in public construction. It is suggested that the revised notification could reinforce the implementation of the provision on the use of BSB-certified bricks for public construction works as reflected in the of Bhutan Schedule Rates (BSR). Moreover, the notification could mandate the use of local bricks in the construction of partition/infill/boundary walls, among others, to ensure that the BSB-certified local bricks are included in the Bill of Quantities (BoQ).

After it was observed that imported bricks that lack BSB certification continued to be utilized and preferred in public constructions, contrary to the government directives mandating the use of BSBcertified products in public infrastructure Department projects, the further supported the cause for BSB-certification of the uncertified brick manufacturers to assure the quality of the products.

As of 2024, there are 119 licensed concrete brick manufacturers in the country. With the aim of increasing the visibility and the use of their products in the public and private construction sector. manufacturers have formed the 'Bhutan Concrete Product Association', certified by the Bhutan Chamber of Commerce and Industry (BCCI) in May 2024. The association aims to work in close cooperation with the member manufacturers to advocate for promotion of BSB-certified local concrete bricks.

4.3.2 Chain Link Promotion

Local chain manufacturers have been in facing challenges accessing domestic market. There are currently 9 licensed chainlink industries in country where 3 industries are fully operational. The Department facilitated the issuance of a 'Value Addition Certificate' to the manufacturers to help avail the 20% domestic preference during the tendering process as per the Procurement Rules and Regulations 2023. Moreover, the Department is encouraging the certification of BSB in chainlink to assure quality.

CHAPTER 5: ACCESS TO INFRASTRUCTURE

5.1. Common Facility Centre at CSI Throm, Changzamtok

The Department inaugurated a Common Facility Center (CFC) at CSI THROM, Changzamtok, Thimphu on 20 December 2023. The building was remodeled into a CFC with GoI-PTA fund support. The main objective of establishing the CFC is to provide the most commonly required technical facilities and services at a minimal cost to startups and CSIs. A similar kind of CFC was established at Changchay CSI Estate, Tsirang.

The CFC provides pre-production and post-production facilities and services such as sorting and grading, dehydrating, grinding and processing, sealing, product packaging, labeling, etc.

The establishment of CFC is envisaged to directly reduce the initial investment and operational cost burden to startups and CSIs. Further, the services of CFC are expected to improve product quality and marketing prospects. The CFC is operated in partnership with a private entrepreneur.

5.2 Industrial Estate/Park

The Department develops and maintains two industrial Estates of Bjemina and Pasakha and four Industrial Parks of Dhamdum, Motanga, Norbugang, and Changchey.

5.2.1 Bjemina Industrial Estate

Bjemina Industrial Estate under Thimphu Dzongkhag spreads over an area of 32.759 acres and has been leased to 32 domestic industries out of which 29 are operational. The number of industries has decreased by 1 from 33 during the FY 2022-23.

5.2.1.1 Sub-sector Classification

The graph below shows the industries by sub-sector in Bjemina Industrial Estate. As of June 2024, there are 32 domestic industries of which twelve industries fall under the other industry category which is followed by eight under forest-based industry, two under agro-based industry and six under service industry.

The graph below illustrates the distribution of domestic industries by subsector in Bjemina Industrial Estate as of June 2024. Out of 32 domestic industries, 12 fall under the "other" category, which includes manufacturers of bricks, ceramic products, and water recycling, followed by 8 forest-based industries, 6 service industries, and 2 agro-based industries.

Additionally, there are 4 approved fabrication activities.




Figure 27: Sub-sector Classification




Figure 28: No. of industries under different investment scales

5.2.2 Pasakha Industrial Estate

Spread across 146 acres, Pasakha Industrial Estate has 39 plots of which 38 plots are leased to the industries. As of June 2024, 29 industries are operational. The number of industries accommodated at the park remains the same.

The graph below shows the industries by sub-sector in Pasakha Industrial Estate. As of June 2024, there are 37 domestic industries of which 29 industries are operational. The industries can be further categorized by the type of business activity.

There are 7 industries that fall under agro and food-based Industry which is followed by 13 mineral and chemical-based industries, 14 under other category industries and four under Fabrication activities. Industries falling under the Other categories include industries such as the plastic industry, manufacturer of bricks, crushing plants, etc.




Figure 30: No. of Industries under different Sub-Sector

Pasakha Industrial Estate has the highest concentration of medium (50.0%) and large -scale (34.2%) industries followed by small -scale Industries (15.8%).




Figure 31: Percentage of industries under different investment scales

5.2.3 Dhamdum Industrial Park

Spread across 169 acres, Dhamdum Industrial Park has a total allocable area of 144.7 acres (Pocket A & C) and has accommodated 44 industries till June 2024. While new provisional letters were

issued, few allotments were terminated or withdrawn. As a result, the total number of industries was almost the same as it was in FY 2022-2023.

5.2.3.2 Sub-sector Classification

The Industrial Park accommodates only clean-tech and low-polluting industries.

The graph below shows the industries by sub-sector in Dhamdum Industrial Park. As of June, 2024, there are 44 industries out of which 3 industries fall under mineral and chemical based industry, 12 under agro and food based industry and 5 under forest and wood -based industry.

There are also 11 metal fabrications and eight under workshops/ service industries followed by 5 under other categories of industries.




Figure 33: No. of Industries under different sub sectors




Figure 34: Percentage of industries under different investment scales

As of June 2024, there are 46.7 Acres of vacant industrial land available on lease for clean-tech/low-polluting industries.

5.2.4 Norbugang Industrial Park

Norbugang, Samtse was identified as one of the viable sites to be developed as an industrial park to relocate the industries from **Jigmeling Industrial** Park. located **Norbugang** is in Samtse Dzongkhag abutting the Samtse-Sipsu highway and adjoining the Diana riverbed. The site is relatively in a flat river bank bounded by hills, river Diana in the north and Sipsu-Samtse highway in the east.

The Industrial Park has an area of 186.773 acres with an allocable area of 138.6 acres. Initially, Norbugang Industrial Park was

only 147.552 acres and an additional 39.221 acres of private land was acquired. Currently, a total of 10 industries are allotted plots at the Industrial Park out of which 8 industries are under construction and 2 are under process for license.




Figure 37: No. of industries under different subsectors




Figure 38: Scale wise Industry categorization at MIP

5.3.6 Changchey CSI Park

The CSIs in Bhutan have limited facilities to enhance and upgrade their products owing to limited technological and other such facilities impeding their growth. Therefore, to ensure the supply of consistent and quality products by the startups and the CSIs, the Department has procured the necessary machinery and equipment to be installed at the park. The equipment consists of the most commonly used or core machines and equipment which they cannot afford on their own. The CFC equipment such as drying and packaging machines are installed and established in the area for the people to avail at any time.

The rationale for establishing a CFC is to provide the most commonly required technical facilities to startups and CSIs in the production and manufacturing sector with the aim to motivate and provide an opportunity for the startups and CSIs to take the benefit of the center to improve upon the quality, productivity of their finished products.

The Changchey CSI park under Semjong Gewog, Tsirang Dzongkhag covers a total area of 2.44 acres. As of June 2024, five proponents are allotted plots which mainly consist of food-based industries in small-scale. The proponents are in various stages of processing their business licenses.
